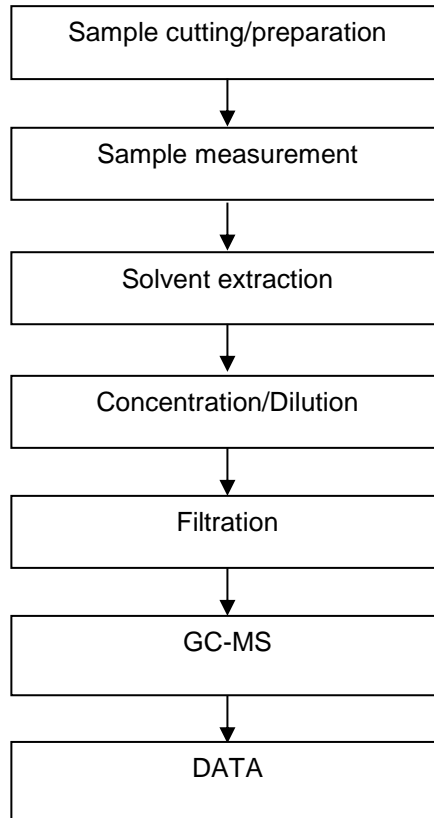

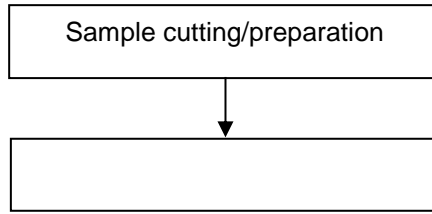

**Phthalates Testing Flow Chart**

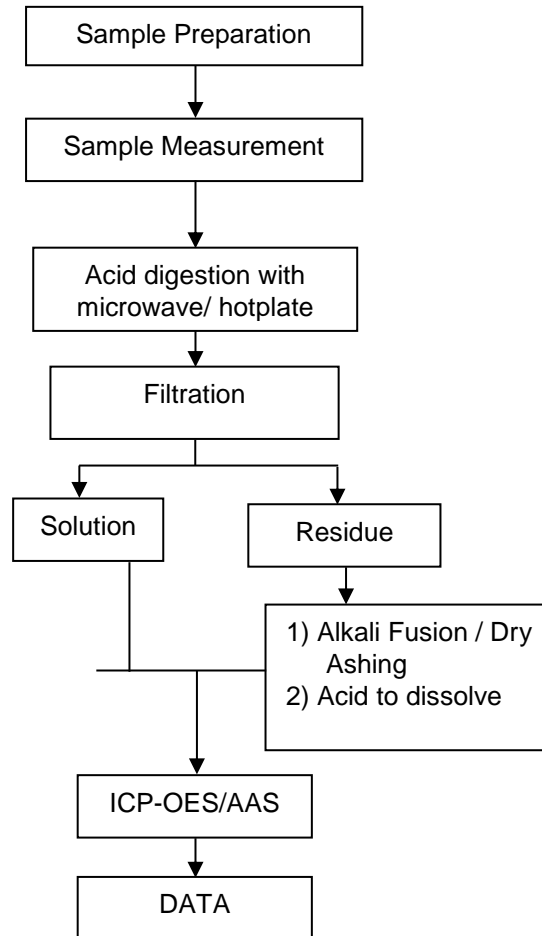


**PBBs/PBDEs Testing Flow Chart**

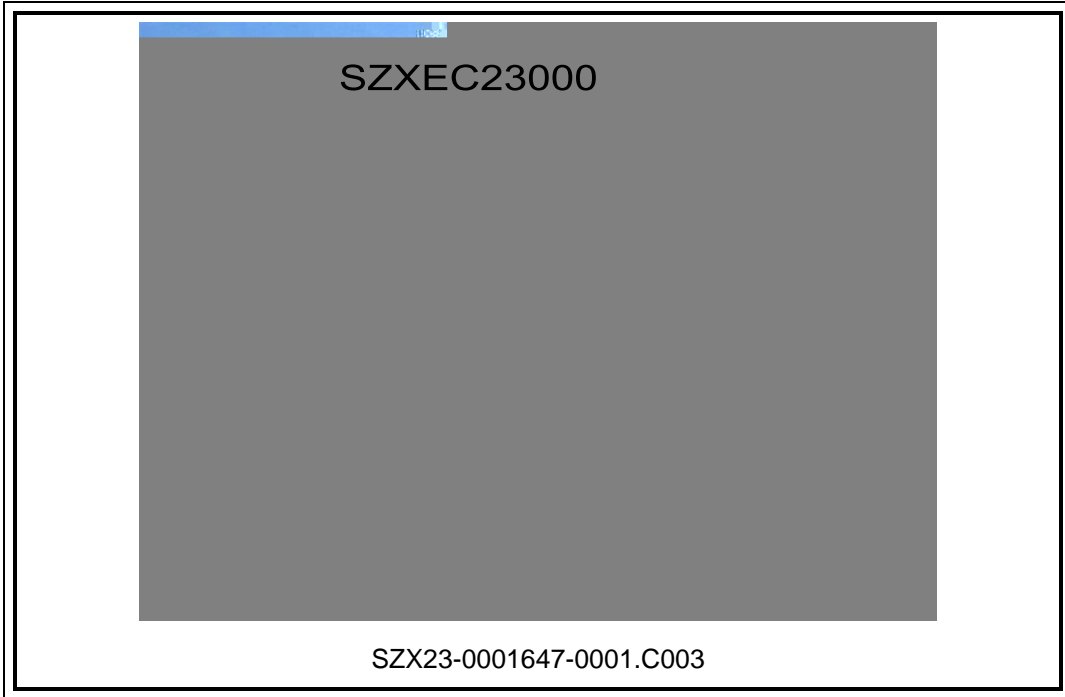
